There are certain rules and requirements along with various information to be collected (such as insurance for legal purposes. We are currently unable to validate. We'll take guidance from other groups and in conversation about what we're doing in our progress and keep them updated.

There are 8 3MT finalists presenting virtually next Tuesday, March 29 from 12:00-1:30pm. Please check our social media feeds as they are filled with links. One judge is a former Chemistry graduate student.

The College has been in discussions with the Sexual Violence Prevention and Response Office (SVPRO) as it relates to graduate students, regarding Policy SC17: Sexual Misconduct and Sexualized Violence Policy (<a href="https://universitycounsel-2015.sites.olt.ubc.ca/files/2021/10/Sexual-Misconduct-Policy SC17.pdf">https://universitycounsel-2015.sites.olt.ubc.ca/files/2021/10/Sexual-Misconduct-Policy SC17.pdf</a>). The goal is to reduce retraumatization in rationales submitted as part of accommodation requests submitted to the College of Graduate Studies by having the rationale consist of just a brief note from SVPRO stating that the accommodation is supported.

Residency requirements have been relaxed as a temporary measure during the pandemic. The College will revisit residency requirements in the next year in light of what has been learned during this time.

An Okanagan-specific policy on graduate students lecturing courses is being developed from the existing Board of Governors policy AP7.

The requirements for transfer from Masters to PhD programs is being revised in light of changes in existing Masters programs. The number of required is proposed to change to 12 credits of graduate coursework, or the coursework requirements of the related Masters, whichever is less.

A member asked about transferring from Masters to a Ph.D: Is this something an MA student needs to know and take up with supervisor or CoGS? At what point is that a possibility? The student initiates it. It has very strict timeline and tight rules. This information can be found in the <u>Calendar</u>.

## 3. Students' Union Report

Kirthana Ganesh is continuing in her role on the UBCSUO Board.

It would be beneficial if non-UBC professional development programs are housed in one central location.

The SUO is drafting a letter explaining why graduate students need more funding which includes outlining general discrepancies between campuses (i.e. increase in living, funding and how it is difficult to produce research, etc.). Please contact the SUO if you would like to provide some input.

General election update: Students had the chance to vote on a referendum to begin the process of designing and finding funding for a new student building. 92% of students voted yes. The SUO now has the ability to develop a physical and financial plan for the building. This building will include club, student, study, recreate, essential business and religious spaces. The building is proposed to also contain significant graduate student space. The location is currently unknown.
