## 1. Chair's Remarks

Welcome back, everyone. It has come to our attention that there has been a misunderstanding regarding the issuance of letters for various purposes related to students' programs. It is essential to clarify that programs are not authorized to issue letters on behalf of CoGS (College of Graduate Studies). Instead, students are required to request letters directly from CoGS for immigration purposes, study permit renewal, enrollment verification, program completion, and post-graduation work permit applications. We collaborate closely with G.E.O (Global Engagement Office) to ensure that these forms cater to the specific needs of students at

## 2. Federal Budget (Paul)

We have an exciting update regarding the federal budget, particularly for graduate students and postdocs. There is potential for significant positive developments in the funding of triagency awards. Proposed changes include harmonizing the awards across Master's, Ph.D., and Postdoctoral levels, at \$27,000 per year for Master's, \$40,000 for Ph.D., and \$70,000 for Postdoctoral awards. While this proposal is pending approval, it marks the first substantial increase in tri-agency funding in over two decades. We are optimistic about its prospects and will keep our fingers crossed that it all goes through.

Another exciting update is that CoGS has hired a new Indigenous Graduate Student Advisor, Eli Kelly (eli.kelly@ubc.ca). He is available to provide comprehensive support, advocacy, and

(First Nation, Métis, and Inuit). He is a wonderful fit for this role and we are excited to have

Following the Senate meeting on April 25th, we have a few updates to share. Firstly, due to

insufficient applicants who could commence the program in Canada on time, the Master of

Design program will not run this year and is rescheduled to begin next year. Conversely, the

Ed.D program is experiencing high demand and is set to commence as scheduled. Additionally,

the Master of Biotechnology program is currently has passed Senate Curriculum and is slated to

be reviewed by Senate.

Food on Campus in the summer and after hours:

Regarding campus food options during the summer and after hours, Paul recently received an

email outlining the current availability. Unfortunately, options are limited, with closures of

Sunshine, Rocket, and Prichard Dining Hall. Presently, only Tim Hortons (operating from 7:30

am to 4 pm), Starbucks, and Comma remain open. There is nothing available after 4 or on

weekends on campus. While Paul intends to contact Food Services to advocate for extended

hours, he holds reservations about the likelihood of success.

In efforts to address this issue, Hamad engaged with individuals in PICNIC, who confirmed their

closure for 10 days until the commencement of Summer Semester 1. Subsequently, they plan

to operate only until 1 pm, possibly offering grab-and-go breakfast options. However, they will

be closed for Summer Semester 2. Collaborating with GSC, there are plans to provide evening

snacks, potentially in the Graduate Collegium or another suitable location for students who

remain on campus.
